Case Study

Public Website and Events Management Portal Development for Centre for High Technology, Government of India

The Client

The Centre for High Technology (CHT) is funded by the Oil Industry Board in India and is part of the Ministry of Petroleum and Natural Gas. It was established in 1987 to anticipate future requirements, and acquire, develop and adopt technologies to advance refinery processes, petroleum products and other related areas.

The Objective

The Client wished to improve public access and information distribution and to enhance internal team processes. The project objectives included three components. First, to enhance and strengthen its online presence and public website, making it more user-friendly and improving the efficiency of its processes so its team members can easily publish news, press releases, media coverage, and publications for public access. Secondly, the Client wished to create a platform for topic discussions among users. The third component of the Client objectives was the need for a Refinery Technology Events Management (RTM) assist event attendees with event registration, transportation and accommodations for events, to support submission of critical information by experts and to capture and process internal approval workflows. All project output would require testing and auditing to ensure government regulations for

data and user security in compliance with the India CERT-IN standards.

The Solution

The Elegant MicroWeb team worked closely with the Client team to define requirements and to design, develop and implement solutions for a seamless roll-out of new features and functionality.

The Elegant MicroWeb team coordinated project approach included:

- Involvement and coordination with stakeholders for detailed requirements and release planning
- Coordination with key product team members to plan for testing
- Involvement with Client team to plan for internal and production releases
- Network, hardware, and technology compatibility and performance
- Definition and implementation of quality and support processes to accommodate upgrades and ongoing maintenance
- Development and deployment of an appropriate training program for users
